### Update on Kennecott Eagle Mine Permit

As of April of this year, we were preparing for the imminent DEQ public meetings for the Kennecott Eagle Mine project. The DEQ abruptly cancelled the hearings a few days before they were to be held. Two fact sheets have just become available from The National Wildlife Federation (TNWF) that explain what happened, and outlines several problems with Kennecott's application. TNWF uncovered documents that had been omitted from the public record that were critical of Kennecott's mine plan. The documents indicated the mine roof could collapse. Since the proposed mine is directly below the Salmon Trout Creek River, subsidence could cause long term catastrophic ecological problems. Once this omission was pointed out to DEQ Director Steve Chester, he postponed the public meetings indefinitely, and ordered a third-party investigation of the DEQ's handling of the mining permit.

Some of the major problems with the mining permit are:

- *Subsidence* (partial or full collapse of the mine)
- *Acid mine drainage*, which occurs when sulfide ores come in contact with air or water.
- *Air pollution* from the 50-foot tall stack that will ventilate the mine. Predictions are that 20 tons of dust containing sulfides and metals will vent to the atmosphere and spread for miles over the countryside each year.
- *Noise* from mining and rock crushing in the area.
- *Transporting* the ore will involve 80 huge truck trips per day on the region's roads. Besides the effects of these large trucks on the roads, no assessment has been made of the ore dust that will disperse from the ore carried in these trucks.

### UPPCO Impoundments Call to Action

The conversion UPPCO's impoundments from wilderness lakes to developed lakes has moved a giant step closer in the past few weeks. If you would like to help block this process (and your help is desperately needed) the time for action is right now.

UPPCO recently released the draft Shoreline Management Plans (SMPs) for their Upper Peninsula impoundments. Shortly after this announcement, public meetings were held to present the documents and allow for limited public input. Having fulfilled this part of their obligation, they are now allowing until **May 21, 2007** for concerned citizens to send comments to them regarding the draft SMPs.

...or call Janet Wolfe at UPPCO, 906.483.4528. She'll need to know which impoundment SMP (Prickett or Bond Falls/Victoria) you'd like. UPPCO has also sent copies to local libraries.

FOLK has been involved with this process from the beginning. We petitioned for a seat on the "focus group" that UPPCO convened to allow input from the community while developing these SMPs. We were denied participation after repeated requests. We were finally allowed to serve as an alternate for the UPEC (Upper Peninsula Environmental Coalition) seat. This allowed us to receive communications from UPPCO as the process developed. (continued)

### UPPCO Impoundments (continued)

There was a great deal of frustration among many of the environmentally oriented members of this focus group. We had very little opportunity to express our opinions, or to discuss the issues during the meetings. It seemed to many of us as though UPPCO was more interested in going through the motions, rather than gathering public input.

After the focus group meetings ended, UPPCO staff worked to produce the SMPs for the Upper Peninsula impoundments. On March 19, the SMPs were released to the public on the UPPCO web page. Members and alternates of the focus group received theirs in paper form in the mail shortly after that. Also on March 19, UPPCO announced that the public meetings to discuss the SMPS would be held in 10 days! This allowed us very little time to publicize these important meetings, submit letters to the editor at local newspapers, or otherwise spread the word. FOLK members were represented at the two meetings regarding the impoundments in the western UP; Bond Falls/Victoria and Prickett.

The format of these meetings again frustrated many of the participants. People with comments and questions were not allowed to speak. Instead, they were required to write on provided 5x7 cards while the meeting was in progress. These cards were picked up and delivered to the moderator, who read the question aloud. The moderator and UPPCO staff were able to choose which cards to read, and in what order. An UPPCO representative then tried to answer the question, but the questioner had no opportunity to clarify the question, or ask follow-up questions unless they filled out another card.

Wilderness lakefront areas of the Keweenaw are being sold and developed at an alarming rate. With enough will and public support, damage to the wilderness aspects of the UPPCO impoundments can be limited. Please consider writing to FERC and expressing your views.
